The **non-refundable** minimum initial payment of **R9 200.00 confirms registration** if a place is available and is deducted from the tuition fees payable. As is the norm in international schools, the balance of fees is due and payable in full by the commencement of studies.

NOTE:

1. The initial payment is due **before** the commencement of studies.
2. Payments can be made by credit card, direct deposit or electronic transfer. For our children's safety, cash payments cannot be accepted on campus. 3. The School reserves the right to withhold course and/or exam results and the provision of tuition services should any fees not be settled timeously.
4. All discounts apply solely to tuition fees and will be withdrawn if payment is late.
 - i) **7.5%** Early Settlement discount applies if tuition fees are settled in full by **31 December** of the previous year.
 - ii) An additional special Founders discount of **5%** will apply to all children registered, with initial payment, by 31 January 2025.
 - iii) **4%** Early Settlement discount applies if no credit is applied for and tuition fees are settled in full **upon commencement of studies**, this being the first day of classes per the academic calendar. For the commencement of studies of new pupils starting after the first day of classes per the academic calendar, this discount also applies for 2025 enrolments.
 - iv) A **sibling discount of 5%** of the tuition fee is awarded to the sibling / siblings of registered pupils (Siblings are two or more children having at least one parent in common (per Birth Certificate), provided they live in the same household, and provided the same person is responsible for their accounts).
 - v) The initial payment is due **before** the commencement of studies.
 - vi) Quarterly payments are calculated subsequent to the minimum initial payment of **R 9 200.00**. Payments are due by **31 March, 31 May and 31 July**.
 - vii) Monthly payments are calculated subsequent to the minimum initial payment of **R 9 200.00**. Payments are due by the **first day of each month** from January to October. Monthly payments can be made via credit card, direct deposit, electronic transfer and debit order.
4. Additional Catering, Aftercare, textbooks, tours and excursions, transport, stationery and uniforms will be billed separately and are not included in the school fees.
